One \$200 Best of Show will be awarded.

Work will be judged in ONE category only per booth. Please carefully review category listing before completing entry form.

Conditions of Entry:

All items must be original work of the exhibitor in concept and execution. We will not accept plastics, sand-art, silk flowers, plaster or ceramics from manufactured molds, vintage jewelry or any item made from kits or pre-manufactured materials such as T-shirts, sweatshirts, towels, etc. Jewelry must be hand-crafted with minimal use of purchased components.

Sharing of booths is not permitted unless artists collaborate to produce a body of work.

Space is limited to approximately 80 exhibitors. While there is no quota in the categories, the jury strives for a well balanced show.

Artists provide all equipment to display and protect their work.
